Served 117,433 individuals, giving them approximately 1 large box and 2 bags of food each, both thru delivery for those whom are home bound and those who came to our self choice pantry, for a total amount provided of 1.8 million pounds of non-perishables, meat, bread, and fresh produce, including 4,000 children to whom we provided food while school was out for the summer. Clothing and household items were also provided to 2,188 families, and 2,303 children received Christmas gifts.
