BETWEEN THE TWO LOCATIONS, GENESIS PROVIDED A TOTAL OF 6,228 CHARITY MEDICAL, DENTAL, MENTAL HEALTH COUNSELING, COMMUNITY HEALTH CONSULTATIONS, MEDICATION ASSISTANCE, AND SPECIALTY CARE COORDINATION ENCOUNTERS TO LOW-INCOME UNINSURED INDIVIDUALS AS AN EXPRESSION OF THE LOVE OF CHRIST. THE BREAKDOWN OF SERVICES IS MEDICAL, 2,664; DENTAL, 994; COUNSELING, 389; COMMUNITY HEALTH, 1,569; MEDICATION ASSISTANCE, 145; AND SPECIALTY COORDINATION, 467.
