LIFEBOAT PROVIDES ASYNCHRONOUS, ANONYMOUS SUPPORT BY TRAINED PEERS AND MENTAL HEALTH PROFESSIONALS. THIS HAS ALMOST 2000 USERS THAT ARE SUPPORTED THROUGH A WARM LINE OF VOLUNTEERS WHO RESPOND WITHIN TWENTY FOUR HOURS. NOMV ATTENDED 10 CONFERENCES, SPOKE AT OVER 100 EVENTS, AND SHARED ONLINE RESOURCES WITH THOUSANDS IN 2024. NOMV'S CLEAR BLUEPRINT IS A PRACTICE CERTIFICATION PROGRAM SUPPORTING THE WELL-BEING OF THE COMMUNITY BY ASSESSING CLINICS FOR TEN WELL-BEING CATEGORIES, PROVIDING RESOURCES AND COACHING TO THE COMMUNITY. WE HAVE OVER 100 CLINICS IN PROCESS AND 43 CERTIFIED. IN 2017, NOMV BEGAN PROVIDING RESOURCES TO THE VETERINARY COMMUNITY IN TWO FORMS: FINANCIAL AND RESOURCE ACCESS.
