THROUGH VSS, USERS CAN SEARCH AND APPLY FOR SUPPORT BASED ON THEIR PRIORITIES, URGENCY, AND PREFERENCES- BACKED BY A TEAM OF LOCALLY BASED COMMUNITY RESPONDERS WHO GUIDE THEM EVERY STEP OF THE WAY.
