In 2024, the organization continued to expand its receivership program, increasing the number of properties under receivership in Tennessee and conducting outreach to establish a receivership program in Dallas, Texas, and to develop a receivership program in Virginia. The organization maintained its ongoing work with the Vacant Property Receivership Consortium in conjunction with academics, other nonprofits, and contacts in Tennessee, Maryland, Massachusetts, and Washington, D.C., to increase knowledge and use of health and safety receivership nationwide. Key accomplishments included the establishment of a Community of Practice comprising more than 100 receivership professionals, with monthly communications and quarterly meetings to facilitate knowledge sharing and collaboration. Additionally, the organization presented the receivership remedy at a national conference with approximately 1,000 attendees to further expand receivership outreach and awareness. These efforts continued to promote receivership as an effective community revitalization tool and strengthened the organization's national network of receivership advocates and practitioners.
