GYNUITY HEALTH PROJECTS IS AT THE FRONTLINE OF GLOBAL RESEARCH AND ADVOCACY EFFORTS TO EXPAND ACCESS TO MEDICATION ABORTION AND IMPROVE THE MANAGEMENT OF OBSTETRIC COMPLICATIONS. IN 2024, WE ORGANIZED A TECHNICAL MEETING OF ORGANIZATIONS ENGAGED IN MEDICATION ABORTION SERVICE DELIVERY, ADVOCACY, AND RESEARCH. BUILDING ON KEY LEARNINGS FROM OUR PROOF-OF-CONCEPT STUDY IN MEXICO EVALUATING USE OF ULIPRISTAL ACETATE (UPA) AS AN ALTERNATIVE TO MIFEPRISTONE FOR MEDICATION ABORTION, WE INITIATED NEW RESEARCH TO FURTHER ESTABLISH THE UTILITY OF UPA IN A COMBINED REGIMEN WITH MISOPROSTOL. ENROLLMENT BEGAN FOR A STUDY EVALUATING THE FEASIBILITY OF MEDICATION ABORTION SERVICES VIA TELEMEDICINE USING MISOPROSTOL ALONE IN ECUADOR AND FOR A STUDY IN MEXICO EXPLORING A NEW 'PERIOD PILLS' REGIMEN USED TO REGULATE MENSTRUATION WITHOUT PRIOR PREGNANCY CONFIRMATION. THIS YEAR, WE PUBLISHED SEVERAL NEW JOURNAL ARTICLES SUMMARIZING COMPLETED STUDIES, INCLUDING ONE IN THE UNITED STATES TESTING A NEW ONLINE PROGRAM TO DETERMINE ELIGIBILITY FOR MEDICATION ABORTION THAT USES A SELF-COMPLETED QUESTIONNAIRE, AND ANOTHER CONDUCTED IN PUBLIC SECTOR FACILITIES IN NEPAL EVALUATING THE POTENTIAL OF AN OUTPATIENT MODEL TO LIMIT INPATIENT CARE AND OVERNIGHT STAYS FOR SECOND TRIMESTER (13-18 WEEKS) MEDICATION INDUCTION. AT GYNUITY, WE PERFORM RESEARCH ON PROMISING MATERNAL HEALTH TECHNOLOGIES AND MODELS OF CARE SUITABLE FOR USE IN LOW-RESOURCE ENVIRONMENTS. IN 2024, WE PUBLISHED THE CLINICAL RESULTS FROM A RANDOMIZED TRIAL UNDERTAKEN IN CENTRAL INDIA CONFIRMING ORAL MISOPROSTOL ALONE AS AN EFFECTIVE OPTION FOR INDUCING LABOR IN PREGNANCIES COMPLICATED BY HYPERTENSION. WE CONTINUED TO ENGAGE STRATEGICALLY WITH PARTNERS AND LEADING HEALTH AUTHORITIES TO SHARE EVIDENCE FOR UPDATING GUIDELINES AND PRACTICES.
