28 FY 2024, the Wilderness Education Association (WEA) made significant strides in advancing the professionalism of outdoor leaders through our core mission of standards, training, and credentialing. Key achievements include: 1. Membership Growth and Retention: WEA successfully increased its Lifetime Membership base by 23%, demonstrating the value members find in our resources and community. 2. Professional Development Initiatives: WEA offered multiple professional development opportunities, including the International Conference on Outdoor Leadership 2024 (ICOL 2024), Outdoor Leadership Experience (OLE), Outdoor Leadership Training Course (OLTC), and Certified Outdoor Leader (COL) courses. enrolled over 200 individuals enrolled representing the U.S., Canada, China, Ireland, Japan, the Philippines, and Taiwan. These initiatives fostered skill development and enhanced the professional capabilities of outdoor educators. 3. Strategic Alliances: We nurtured strategic alliances with key stakeholders, resulting in collaborative efforts to promote standards in outdoor leadership. These partnerships have contributed to the recognition of WEAs curriculum and credentialing process as industry benchmarks. 4. Research and Advocacy: WEA hosted two keynote speakers, 11 general sessions, five practical sessions, two research sessions, and a post-conference session at ICOL 2024. These sessions focused on outdoor living skills, planning and logistics, risk management, environmental integration, education, leadership, judgment and decision-making. We also collaborated with the Journal of Outdoor, Recreation, Education Leadership (JOREL) in advocacy efforts to promote outdoor education, education, and leadership at the national level. 5. Community Engagement: The WEA National Office and Executive Chair participated in the 30th Annual Adventure Education Conference. Through a range of community-focused events and activities, WEA enhanced its visibility and presence within the industry. Additionally, the WEA ICOL Auction raised \$1,080 for the Scholarship Fund, showcasing our community's commitment to supporting the next generation of outdoor leaders. These achievements underscore WEAs commitment to advancing the field of outdoor leadership and ensuring that our standards and training programs continue to support the growth and professionalism of outdoor educators
