IN 2024, MOBILIZE RECOVERY TOOK ITS ADVOCACY EFFORTS ON THE ROAD WITH A NATIONWIDE BUS TOUR THAT MADE 27 STOPS IN 13 STATES. THIS TOUR BROUGHT TOGETHER INDIVIDUALS WITH LIVED EXPERIENCE OF SUBSTANCE USE DISORDERS, COMMUNITY LEADERS, AND ALLIES TO AMPLIFY THE VOICES OF THE RECOVERY COMMUNITY AND DRIVE MEANINGFUL CHANGE. THE TOUR SERVED AS A PLATFORM TO BUILD CAPACITY FOR ORGANIZED CIVIC ADVOCACY, FOSTERING CONNECTIONS AND PROVIDING RESOURCES TO ADVOCATES IN COMMUNITIES ACROSS THE UNITED STATES. THE YEAR'S EFFORTS ALSO INCLUDED THE ANNUAL MOBILIZE RECOVERY DAY OF SERVICE, A NATIONWIDE INITIATIVE THAT UNITED OVER 3,000 VOLUNTEERS AT OVER 600 SERVICE PROJECT EVENTS TO DEMONSTRATE THE POWER OF RECOVERY AND GIVE BACK TO COMMUNITIES.
