 WELLBEING INTERNATIONAL AIMS TO PROMOTE OPTIMAL WELL-BEING FOR PEOPLE ANIMALS AND THE ENVIRONMENT THROUGH COLLABORATION EDUCATION DIRECT CARE AND SCIENCE. IT WAS FOUNDED ON THE PREMISE THAT PEOPLE ANIMALS AND THE ENVIRONMENT ARE DEEPLY CONNECTED AND RELY ON EACH OTHERS WELL-BEING.

WBIS OUTREACH HAS GROWN SUBSTANTIALLY. WEBSITE PAGE VIEWS OF 220,000 IN 2024 DOUBLED COMPARED TO 2023 AND SOCIAL MEDIA IMPRESSIONS ROSE BY 33% OVER 2023. WBI DISTRIBUTES ACCURATE DATA-DRIVEN MATERIALS THAT SUPPORT ITS PROJECTS AND ADVOCACY. WBISR OFFERS FULL-TEXT ACCESS TO RELEVANT ACADEMIC PAPERS AND REPORTS. IN 2024 THE WBISR HOSTED MORE THAN 6,200 OPEN-ACCESS DOCUMENTS RELATED TO THE WELL-BEING OF PEOPLE ANIMALS AND THE ENVIRONMENT.
