UNLESS APPROVED BY TWO-THIRDS OF THE VOTES CAST AT A MEETING AT WHICH A QUORUM IS PRESENT, CAUSE THE ARTICLES OF INCORPORATION OF THE CORPORATION OR THESE BYLAWS TO BE AMENDED IN A MANNER TERMINATING ALL PARTNERSHIPS OR ANY CLASS OF PARTNERSHIPS.
