TO ADVANCE OUR MISSION OF PROMOTING A STRONG AND PROUD AMERICAN FOREIGN POLICY, THE VANDENBERG COALITION (TVC) FOCUSED OUR EFFORTS FOR 2024 ON FIVE MAIN POLICY PRIORITIES: SUSTAINING BIPARTISAN SUPPORT FOR THE U.S.-ISRAEL ALLIANCE; DEFENDING AND SUSTAINING U.S. MILITARY AID TO UKRAINE; ENSURING THE UNITED STATES HAS THE RESOURCES TO DEFEAT AND DETER CHINA; RESTORING AMERICAN DETERRENCE THROUGH A STRONG NATIONAL DEFENSE; ESTABLISHING VANDENBERG AS A KEY ADVOCATE FOR A STRONG BORDER SECURITY POLICY. WITHIN THESE CATEGORIES, OUR MOST SIGNIFICANT ACTIVITIES INCLUDED: 1.
