Low levels of mobility can lead to isolation from friends and lack of access to the community as well as to critical services, food and health care. Operating on short frequencies, seven days/week, commuters, students, downtown workers, visitors, seniors and people with disabilities are all well served by the HOP. Using electric buses, the HOP helps reduce pollution, improves air quality, mitigates traffic and supports the local economy by increasing accessibility to the main areas of the city. The HOP provided 545,487 trips in 2024. Form 990, Page 2, Part III: Question 4d. Under contract agreement with the Regional Transportation District (RTD), Via operates FlexRide transportation services in 24 metro Denver-Area Communities. FlexRide is a hybrid demand responsive service operating in specific communities where fixed routes are generally not cost effective. Drivers take ride requests directly from a passenger. Designed to connect people to the RTD Park-n-Rides during peak hours of commuter travel, the service is open to anyone living or working within the defined geographic area. Via's FlexRide program provided 180,284 trips in 2024. Via was awarded additional FlexRide service beginning July 1, 2024.</p>
