ALL ROADS PROVIDES HOUSING, STREET OUTREACH, DAY AND OVERNIGHT SHELTER, MEALS, AND OTHER SUPPORTIVE SERVICES TO ADULTS EXPERIENCING HOMELESSNESS IN BOULDER COUNTY, COLORADO. DURING THE PERIOD FROM OCTOBER 1 THROUGH DECEMBER 31, 2024, ALL ROADS PROVIDED 16,560 BED NIGHTS AND SERVED 33,606 MEALS TO 657 ADULTS AT ITS OVERNIGHT SHELTER FACILITY.
