("NCI") EMPLOYEES, OFFICERS, AND DIRECTORS, AND ANY OTHER INDIVIDUALS DESIGNATED BY THE BOARD OF DIRECTORS OF NCI (THE "BOARD") FROM TIME TO TIME AS SUBJECT TO THIS POLICY (COLLECTIVELY, "SUBJECT PERSONS"). THIS POLICY PROVIDES NCI WITH PROCEDURES AND STANDARDS TO GUIDE SUBJECT PERSONS IN THE PERFORMANCE OF THEIR DUTIES AND TO PREVENT SUBJECT PERSONS FROM BENEFITING FROM OR HOLDING AN EQUITY POSITION IN ANY INTELLECTUAL PROPERTY, LICENSING, OR BUSINESS ENTITY SUPPORTED OR FUNDED BY NCI. IN ADDITION TO THE NCI-SPECIFIC REQUIREMENTS UNDER THE ABOVE-REFERENCED STATUTE, THE DIRECTORS AND OFFICERS OF NCI OWE FIDUCIARY DUTIES TO NCI UNDER CHAPTER 55A OF THE NORTH CAROLINA GENERAL STATUTES, OTHERWISE KNOWN AS THE NORTH CAROLINA NONPROFIT CORPORATION ACT, TO ACT IN GOOD FAITH, WITH THE CARE AN ORDINARILY PRUDENT PERSON IN A LIKE POSITION WOULD EXERCISE UNDER SIMILAR CIRCUMSTANCES, AND IN A MANNER REASONABLY BELIEVED TO BE IN THE BEST INTERESTS OF NCI. THIS POLICY IS INTENDED TO SUPPLEMENT AND NOT SUPERSEDE ANY APPLICABLE LAW, INCLUDING (WITHOUT LIMITATION) THE PROVISIONS OF THE NORTH CAROLINA NONPROFIT CORPORATION ACT REGARDING DIRECTOR CONFLICTS OF INTEREST. NOTHING IN THIS POLICY AUTHORIZES NCI OR ANY SUBJECT PERSON TO ENGAGE IN ANY ACT OF SELF-DEALING, INUREMENT OR ANY OTHER ACT PROHIBITED BY APPLICABLE LAW OR REGULATION.
