SEVENTY-FIVE PERCENT OF THE DIRECT LABOR EMPLOYEES ARE SEVERELY DISABLED AND THE AVERAGE WAGE OF THE DIRECT LABOR IS 15.00 AN HOUR PLUS BENEFITS.
