**28** Since inception in 2017, Wild Warrior Adventure has served over 330 veterans and service members through adventure-based retreats in confidential environments. WWA has conducted over 40 retreats serving Warriors to improve camaraderie, coping mechanisms, and reducing the effects of combat trauma and moral injury. The effects of the program include increased quality of life, better skills to manage symptoms of trauma, a renewed hope, and new purpose and mission. Alumni have reported significant increase in quality of relationships, stronger support structures, and a more clearly defined purpose resulting in overall improvement in quality of life.
