IN THE LAST CALENDAR YEAR, MAHN TESTED ITS INNOVATION PROTOTYPE PROGRAM FEATURING NINE PROTOTYPES (SCALABLE SOLUTIONS) UTILIZING HUMAN-CENTERED DESIGN.
