THESE PROGRAMS SPANNED 601 PUBLIC, CHARTER, TRIBAL, HOME, PRIVATE, AND JUVENILE DETENTION SCHOOLS, REPRESENTING 102 CITIES AND ALL 15 COUNTIES STATEWIDE.
