IN 2024, HSU PROVIDED OVER 13,000 AFFORDABLE SPAY/NEUTER SURGERIES, ADMINISTERED 121,000 VACCINATIONS, ADOPTED 6,363 PETS INTO LOVING HOMES, AND EXPANDED SERVICES TO HELP PETS AND PEOPLE STAY TOGETHER. THROUGH CLINICS, EDUCATION, SHELTER DIVERSION, AND MORE, HSU REMAINS UTAH'S LEADING PRIVATE ANIMAL WELFARE ORGANIZATION.

HSU'S VETERINARY CLINICS IN MURRAY AND ST. GEORGE PROVIDED ACCESSIBLE CARE TO TENS OF THOUSANDS OF ANIMALS IN 2024. WE PERFORMED 13,013 SPAY/NEUTER SURGERIES AND ADMINISTERED 121,230 VACCINATIONS. RENOVATIONS AND STAFFING EXPANSIONS IN ST. GEORGE ALLOWED US TO INCREASE CAPACITY, INCLUDING 1,000 ADDITIONAL SURGERIES, 200 MORE DENTAL PROCEDURES, AND SERVICE TO 3,000 ADDITIONAL PET GUARDIANS. OUR MURRAY CLINIC LAUNCHED A NEW WELLNESS CLINIC, PROVIDING PREVENTATIVE CARE AND BLOODWORK FOR THE FIRST TIME.

WE ASSISTED 8,277 ANIMALS THROUGH THE PET RESOURCE CENTER. OUR PET RETENTION AND SHELTER DIVERSION PROGRAMS PROVIDED MEDICAL, BEHAVIORAL, AND MATERIAL SUPPORT TO MORE THAN 2,000 ANIMALS AND DISTRIBUTED 5,300 BAGS OF PET FOOD TO LOCAL PANTRIES AND HUMAN SERVICE CENTERS. THESE SERVICES HELPED FAMILIES IN CRISIS KEEP THEIR PETS AND AVOID UNNECESSARY SHELTER INTAKE.
