SEE SCHEDULE ORCUSA IS THE MEMBERSHIP ASSOCIATION FOR THE TEN NATIONAL RESETTLEMENT AGENCIES AND MORE THAN THIRTY OTHER NONPROFITS SERVING AND ADVOCATING FOR REFUGEES AND OTHER FORCIBLY DISPLACED PEOPLE. RCUSA PROVIDES ITS MEMBERS WITH A PLATFORM FOR COORDINATING ADVOCACY, COMMUNICATIONS, AND RESETTLEMENT OPERATIONS, ARRANGES FOR ITS MEMBERS REGULAR HIGH-LEVEL MEETINGS WITH GOVERNMENT OFFICIALS, AND FACILITATES ACCESS TO INTERNATIONAL REFUGEE POLICY ARENAS. RCUSA WORKS TO IMPROVE AND EXPAND RESETTLEMENT ASYLUM, HUMANITARIAN PROTECTION, AND INCLUSION FOR FORCIBLY DISPLACED POPULATIONS; STRENGTHEN THE COLLECTIVE POWER AND EFFECTIVENESS OF RCUSA MEMBERS AND PARTNERS IN DELIVERING RESPONSIVE, EQUITY-FOCUSED POLICIES AND PROGRAMS AND DRIVING SYSTEMIC CHANGE; AND ENHANCE THE ROLE OF FORCIBLY DISPLACED PEOPLE AS LEADERS, EXPERTS, AND ADVOCATES TO INFLUENCE POLICIES, PROGRAMS, AND PERCEPTIONS.

RCUSA STRENGTHENS THE COLLECTIVE POWER AND EFFECTIVENESS OF ITS MEMBERS AND PARTNERS IN DELIVERING RESPONSIVE, EQUITY-FOCUSED POLICIES AND PROGRAMS AND DRIVING SYSTEMIC CHANGE. RCUSA CARRIES OUT THIS WORK BY PROVIDING A NUMBER OF ONGOING PLATFORMS FOR OUR MEMBER ORGANIZATIONS TO COORDINATE ADVOCACY, COMMUNICATIONS, AND RESETTLEMENT OPERATIONS, INCLUDING THROUGH CONVENING OF MONTHLY OR BIWEEKLY MEETINGS OF MEMBER-LED, STAFF FACILITATED COMMITTEES AND WORKING GROUPS. RCUSA ALSO FACILITATES PERIODIC IN-PERSON AND VIRTUAL MEETINGS WITH US GOVERNMENT OFFICIALS, AND HOSTS RCUSA POLICY CENTER WEBINARS ON KEY TOPICS OF INTEREST TO OUR MEMBERSHIP. TO BE CONTINUED ON SCHEDULE OIN EARLY 2024, THROUGH OUR INTERACTION WITH THE FEDERAL GOVERNMENT, RCUSA HELPED UNLOCK \$82 MILLION IN ADDITIONAL FEDERAL FUNDING FOR REFUGEE HOUSING. THROUGHOUT THE YEAR, RCUSA ADVOCATES FOR MEASURES TO IMPROVE AND EXPAND RESETTLEMENT ASYLUM, HUMANITARIAN PROTECTION, AND INCLUSION FOR FORCIBLY DISPLACED POPULATIONS. A HIGHLIGHT OF THIS WORK IS OUR ANNUAL NATIONAL ADVOCACY DAYS EVENT, RCUSA BRINGS CONSTITUENTS FROM ACROSS THE UNITED STATES TO WASHINGTON DC TO SPEAK TO MEMBERS OF CONGRESS AND THEIR STAFFS ABOUT THE IMPORTANCE OF REFUGEE PROTECTION AND THE VITAL CONTRIBUTIONS OF RESETTLED REFUGEES, ASYLEES, AND OTHER FORMERLY DISPLACED PERSONS TO LOCAL COMMUNITIES ACROSS THE COUNTRY. IN MAY 2024, RCUSA'S NATIONAL ADVOCACY DAYS DREW SOME 300 CONSTITUENT-ADVOCATES FROM 35 STATES, ABOUT HALF OF THEM WITH LIVED EXPERIENCE OF FORCED DISPLACEMENT, TO MEETINGS WITH 147 CONGRESSIONAL OFFICES. DURING ADVOCACY DAYS, MORE THAN 100 FORMERLY DISPLACED PERSONS ALSO PARTICIPATED IN A DAY-LONG REFUGEE LEADERSHIP TRAINING EVENT. RCUSA IS A FOUNDING PARTNER IN THE US REFUGEE ADVISORY BOARD, A PIONEERING NON-GOVERNMENT BODY THAT CHANNELS THE PARTICIPATION OF FORMERLY DISPLACED PEOPLE INTO US GOVERNMENT DELEGATIONS TO RELEVANT INTERNATIONAL REFUGEE POLICY BODIES, THUS PROVIDING A MECHANISM TO ENSURE THERE IS MEANINGFUL ENGAGEMENT BY REFUGEES IN POLICIES AFFECTING THEM. RCUSA IS ALSO WORKING TO IMPROVE THE MEASURES USED TO GAUGE SUCCESSFUL INTEGRATION OF REFUGEES INTO LOCAL COMMUNITIES IN THE US, SO THAT THE WAY INTEGRATION IS MEASURED BETTER CAPTURES THE RANGE OF INTERESTS, NEEDS, PRIORITIES, AND EXPERIENCES OF REFUGEES THEMSELVES. RCUSA HELPS REPRESENT THE REFUGEE-SERVING CIVIL SOCIETY COMMUNITY IN GLOBAL REFUGEE POLICY FORUMS. RCUSA ASSEMBLED AND LED US CIVIL-SOCIETY DELEGATIONS TO THE FEBRUARY 2024 WORKING GROUP ON RESETTLEMENT MEETING (HELD IN SYDNEY, AUSTRALIA), AND THE JUNE 2024 CONSULTATIONS ON RESETTLEMENT AND COMPLEMENTARY PATHWAYS (HOSTED BY UNHCR IN GENEVA, SWITZERLAND). RCUSA PARTICIPATED (ALONGSIDE COUNTERPART CIVIL SOCIETY ORGANIZATIONS IN CANADA, AUSTRALIA, AND NEW ZEALAND) IN THE LAUNCH OF A NEW INTERNATIONAL NETWORKING PLATFORM FOR REFUGEE RESETTLEMENT PRACTITIONERS, THE INTERNATIONAL REFUGEE INTEGRATION AND SETTLEMENT EXCHANGE (IRISE). RCUSA FURTHER SERVED ITS MEMBER ORGANIZATIONS IN 2024 BY ORGANIZING TWO PRESIDENTIAL TRANSITION DOCUMENTS TO HELP GUIDE REFUGEE ADVOCACY APPROACHES IN THE EVENT OF EITHER A BIDEN OR TRUMP ELECTORAL VICTORY IN THE NOVEMBER 2024 ELECTION.
