LexCollective is a not-for-profit organization that addresses the most extreme forms of social, racial, economic, and environmental injustices around the world, such as mass atrocities, human trafficking, environmental destruction, and other related crimes. The organization works to increase access to justice for victims and survivors, many of whom are women, children, and marginalized persons, of these injustices and other serious human rights abuses. The organization envisions a world community where interdisciplinary, high-quality legal services are available to all individuals and communities, including those most impacted by armed conflict, state oppression, and the climate and environmental emergency.

We utilize innovative legal tools and collaborative strategies to address interconnected human rights issues faced by marginalized communities worldwide. Our work has three pillars: (1) network bridging and building; (2) multi-directional knowledge sharing and exchange; and (3) innovative legal solutions. In 2024, we have provided training and mentoring related to investigating in East Africa; conducted investigations and provided legal support services related to the ongoing conflict situation in Ukraine and the greater region; and produced materials assessing legal aid in Cambodia.
