Program Service Accomplishments 2024In 2024, Bridge Recovery delivered a total of 9,614 recovery services, reflecting a year of significant outreach, collaboration, and support for individuals on their recovery journeys across North Georgia.Mutual Support Recovery Groups:The cornerstone of Bridge Recoverys work continued to be its Mutual Support Recovery Groups, with 4,774 services provided. These groups included NA, AA, Yoga, and Overcomers Outreach, offering consistent, compassionate spaces for individuals to share experiences, strengthen coping skills, and build supportive networks.Peer Engagement and First-Time Support:Bridge Recovery conducted 625 peer check-ins, meeting participants at Accountability Courts, the Daily Reporting Center, Drug Court, and through one-on-one sessions in person, over the phone, or during transportation services. In addition, 1,063 individuals were assisted for the first time, connecting them with critical services and resources to support their recovery journey.Social and Community Connections:Fostering a sense of belonging remained a vital focus, with 2,909 social support activities hosted. These included hikes, BBQs, and other recovery-centered events, creating healthy environments for peer interaction and community building.Bridge Recovery also strengthened its partnerships through 1,111 community collaboration efforts, working alongside recovery residences, Recovery Community Organizations (RCOs), prevention task forces, and other stakeholders to broaden education and awareness about recovery.Other Support and Training:The organization provided 266 other support services, such as transportation, housing and employment assistance, community service opportunities, and family support. Additionally, 50 recovery training programs were offered to educate community members and partners in Recovery Oriented Systems of Care, ensuring that recovery principles were shared and sustained within the wider community.
