The organization is a nonprofit corporation that shall be organized and operated exclusively for charitable purposes and other programs and projects as described in 170(c)(2)(B), 501(c)(3), 2055(a)(2), and 2522(a)(2) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws. The organization principally exists to (a) assist federal employees who faced job insecurity, including threat of termination of employment and discrimination due to COVID-19 vaccine mandates; (b) support federal employees who seek to improve accountability, transparency, and uphold constitutional rights within the federal service by building a supportive coalition; (c) provide transparency to the American public through Freedom of Information Act requests and through the podcast; (d) solicit and receive funds for the accomplishment of the above purposes; and (e) pursue any other lawful purpose permitted to be pursued by a charity (or, by a private foundation)

Member Services - Feds for Medical Freedom was established in September 2021 to assist federal employees facing termination due to the COVID-19 vaccine mandates. In September 2023, Feds for Medical Freedom began doing business as Feds For Freedom to continue supporting federal employees and to bring greater accountability, integrity and transparency to the federal government. We have 30 chapters serving thousands of members across more than 20 states nationwide. We have offered guidance to our members on how to spot government overreach and use the system to prevent it.

Support and Education - The organization has continued to host calls for membership on a variety of topics including but not limited to Equal Employment Opportunity, Religious Accommodations, and DEI. We also provide regular volunteer opportunities. We educate our membership and public through our podcast and Sub-stack, providing weekly content on many topics, all focusing on holding our government accountable.

Litigation - The organization has organized and provided legal assistance with more than 16 class action lawsuits pending at the Equal Employment Opportunity Commission or in Federal Court. We successfully litigated our initial lawsuit Feds for Medical Freedom v. Biden up to the United States Supreme Court. Due to this lawsuit, we received an injunction that was in effect for two years and we were able to protect the careers of an estimated 400,000 federal employees up through and past the rescission of the Executive Order that created the mandates. We have also partnered with other non-profit organizations to support legal action against federal labor unions.
