OTHER CIVITAS PERSONNEL ALSO PROVIDED AND CONTINUE TO PROVIDE RESEARCH, PLANNING AND STRATEGIC CONSULTING SERVICES TO CENTERLINE LIBERTIES. NONE OF THOSE OTHER INDIVIDUALS IS AN OFFICER OR DIRECTOR OF CENTERLINE LIBERTIES.
