SUPPORTS INCLUDE DAILY LIVING SKILLS, PERSONAL CARE, SHOPPING MEDICAL APPOINTMENTS, RESPITE SERVICES, AND MORE AS THE INDIVIDUAL REQUIRES. CUSTOMERS ARE REFERRED TO CASCADE CONNECTIONS THROUGH THE DEVELOPMENTAL DISABILITIES ADMINISTRATION AS WELL AS THE AGING AND ADULT SERVICES BOTH ARE SUB-DEPARTMENTS OF THE WASHINGTON STATE DEPARTMENT OF SOCIAL AND HEALTH SERVICES. THE CUSTOMERS OF CASCADE CONNECTIONS ARE REFERRED TO US THROUGH THE DIVISION OF VOCATIONAL REHABILITATION DEVELOPMENTAL DISABILITIES ADMINISTRATION DEPARTMENT OF SERVICES FOR THE BLIND ALL OF WHICH FALL UNDER THE WASHINGTON STATE DEPARTMENT OF SOCIAL AND HEALTH SERVICES.
