TURTLE ISLAND RESTORATION NETWORK WORKS TO RECOVER ENDANGERED MARINE SPECIES THROUGH HANDS-ON CONSERVATION, RESEARCH, BIOLOGICAL MONITORING, AND ADVOCACY CAMPAIGNS. THROUGH ITS OCEANS PROTECTION PROGRAMS, THE ORGANIZATION WORKS TO REFORM FISHERIES POLICIES, CREATE MARINE PROTECTED AREAS, SAFEGUARD KEY SEA TURTLE NESTING BEACH HABITATS, BUILD COMMUNITY ENGAGEMENT, AND EDUCATE MORE THAN 3,000 STUDENTS EACH YEAR. SINCE 1989, IT HAS WORKED TO PROTECT AND RESTORE POPULATIONS OF ENDANGERED SEA TURTLES AND THEIR HABITATS. TODAY THE ORGANIZATION USES ITS SUCCESSFUL STRATEGIES TO SAFEGUARD WHALES, DOLPHINS, SEALS, SEABIRDS, SHARKS, AND OTHER MARINE LIFE. IN SO DOING IT ALSO PROTECTS HUMAN COMMUNITIES WHICH RELY ON HEALTHY OCEANS ECOSYSTEMS FOR NUTRITIONAL, AESTHETIC, SPIRITUAL, AND RECREATIONAL NOURISHMENT. THROUGH ITS CALIFORNIA-BASED WATERSHED PROGRAM, TURTLE ISLAND ALSO WORKS TO PROTECT THE LARGEST SURVIVING POPULATION OF THE CRITICALLY ENDANGERED WILD COHO SALMON AND STEELHEAD TROUT BY RESTORING HABITAT AND ENGAGING HUNDREDS OF VOLUNTEERS EACH YEAR TO RAISE NATIVE PLANTS.
