WE CONVENED MULTIPLE TIMES AS A NETWORK WITH OUR MEMBER ORGANIZATIONS TO ANALYZE AND PREPARE FOR ISSUE CAMPAIGNS ACROSS THE COUNTRY. WE EQUIPPED OUR 42 FEDERATION DIRECTORS AND STAFF TO INCREASE POLITICAL ENGAGEMENT AND EDUCATION IN THEIR LOCAL CONTEXT WITH THEIR BASES.
