The Family Housing Program is aimed at reducing and eliminating child homelessness and provides intensive case management paired with a variety of targeted interventions to homeless families with children, including but not limited to: emergency hotel placements, transitional housing, permanent supportive housing, and rapid rehousing services.

The Mental Health Program provides flexible, low-barrier, mobile clinical mental health services to individuals and families currently experiencing or exiting homelessness who have barriers to engaging in traditional mental health services. These services include individual therapy, family therapy, therapeutic groups, workshops, crisis intervention and support, and mental health case management.

The Parent Support Program provides crucial support to caregivers experiencing or recovering from homelessness.
