SCIENCE, PUBLIC EDUCATION & ENGAGEMENT: BCPP is a leader in the breast cancer and environmental health scientific communities. Our science program translates, disseminates and communicates evidence of environmental links to breast cancer. This informs our programmatic work and shapes the national breast cancer prevention research agenda. Additionally, key to all of our work is building awareness about toxic chemicals and radiation linked to the disease and mobilizing a growing community to take action for breast cancer prevention. We do this through public education, social media advocacy and by participating in conferences, meetings and other events.

Our sophisticated understanding of the political and regulatory landscape and our track record of developing successful policy initiatives makes BCPP uniquely qualified to lead cutting-edge public policy initiatives, and to serve as a trusted resource to state and federal decision-makers.
