THE HORTICULTURE PROGRAM CURATES, INSTALLS, AND MAINTAINS THE GARDEN'S LIVING COLLECTION, WHICH ENCOMPASSES 78 ACRES OF NATIVE PLANTS DRAWN FROM CALIFORNIA'S FLORISTIC PROVINCE, AS WELL AS HISTORIC LANDMARKS AND FEATURES DATING BACK TO 1806. THE PROGRAM ENSURES GUESTS EXPERIENCE SEASONAL WILDFLOWER DISPLAYS, ECOSYSTEM-THEMED SECTIONS FROM DESERT TO REDWOOD GROVES, AND GARDENS THAT CELEBRATE CALIFORNIA'S TAXONOMIC DIVERSITY, FROM RARE SPECIES TO ICONIC FIXTURES SUCH AS THE GOLDEN POPPY. NEWER GARDEN EXHIBITS EXPLORE "PLANTING WITH PURPOSE" THEMES SUCH AS WATER CONSERVATION, ATTRACTING WILDLIFE, AND HOME DEMONSTRATION GARDENING.
