THE SHEA CENTER PROVIDES THERAPEUTIC RIDING AND EQUINE ASSISTED THERAPY, WHICH ARE MEDICALLY RECOGNIZED FORMS OF THERAPEUTIC INTERVENTION FOR A NUMBER OF DISABILITIES. THE SHEA CENTER'S CLIENTS HAVE COGNITIVE OR PHYSICAL DISABILITIES, SUCH AS CEREBRAL PALSY, LEARNING DISABILITIES, DOWN SYNDROME, MULTIPLE SCLEROSIS, SPINAL CORD OR HEAD INJURIES, AND AUTISM. THE SHEA CENTER HAS PARTNERSHIPS WITH OTHER SERVICE ORGANIZATIONS AND LOCAL SCHOOL DISTRICTS, AND IS ALSO AN INTERNATIONAL TRAINING FACILITY FOR THE INDUSTRY. THE SHEA CENTER ALSO PROVIDES MENTAL HEALTH SERVICES THROUGH EQUINE ASSISTED LEARNING AND EQUINE FACILITATED PSYCHOTHERAPY PROGRAMS CONDUCTED BY A LICENSED MENTAL HEALTH PROFESSIONAL ON STAFF. ADDITIONALLY, THE SHEA CENTER PARTNERS WITH LOCAL VETERANS CENTERS TO PROVIDE EQUINE ASSISTED ACTIVITIES AND THERAPIES FOR COMBAT VETERANS AND FAMILY MEMBERS.
