KRC provides Korean-language legal services and education to low-income immigrant KoreanAmericans, Asian Americans and Asian Americans and Pacific Islanders, and other low-income communities of color. Recognized by the Dept of Justice Board of Immigration Appeals, accredited KRC staff conduct a variety of immigration legal services at low to no cost. We provide linguistically and culturally appropriate legal services to our community. In 2024, KRC assisted directly and provided information to over 3,000 community members.

4b (Code:) (Expenses \$ **233,434** including grants of \$) (Revenue \$)
KRC's Housing Program provides Rental Housing Counseling and Financial Management/ Budget Counseling to the most vulnerable members of the Korean American community of greater Los Angeles and Orange County. We seek to create safer communities and empower low-income residents of all ages through linguistically and culturally competent housing counseling including affordable housing counseling, tenants' right education and resolving financial challenges. In 2024, KRC assisted directly and provided information to more than 2,500 community members.

KRC Social Service/Health Access program is used primarily but not exclusively by low-income Korean American seniors. Because language access is a major concern in our community, many individuals depend on KRC to assist them with everything from referrals, translating utility bills to assistance in applying for services such as Medi-Cal and Cal-Fresh. In 2024, KRC also conducted COVID-19 outreach, education and vaccine clinics. Overall KRC assisted over 5,000 community members.
