Spurwink offers expert support, treatment and guidance to children and adolescents through a continuum of care that includes residential treatment, specialized schools, and therapeutic foster homes in 1) residential treatment facility in Cumberland County serving about 20 youth per year; 2) three Special Purpose Private Schools in Cumberland, Androscoggin and Kennebec counties and a Therapeutic Pre-School in York County serving 150 students per year; and 3) treatment foster homes in southern and central Maine serving about 30 children per year. Each year, we support over 200 young people in overcoming challenges and building brighter futures.

Spurwink's outpatient and community-based programs reach approximately 10,000 Mainers each year, providing accessible mental health care, substance use disorder treatment, and specialized support for those facing trauma or abuse. Our innovative services including outpatient therapy (in public school settings, outpatient offices, and primary care practices), medication management, behavioral health homes, Assertive Community Treatment, Opioid Health Home, Crisis Receiving Center, Certified Community Behavioral Health Center, trauma focused treatment for refugees, child abuse evaluations, as well as a number of contracted services for the Maine Department of Health and Human Services ensure that every individual receives the help they need, wherever they are.

Spurwink's adult residential programs foster independence and dignity for nearly 80 adults with intellectual, developmental disabilities and/or autism. This strategic integration increased access to care and strengthened our impact in the communities we serve. The Next Gen Internship Program is a grant-funded initiative by Spurwink that offers paid internships to Maine college students, fostering nonprofit leadership and mental health careers through structured cohorts, capstone projects, and an evolving alumni network. Spurwink's Internship Incubator is a grant-funded program offering paid internships in mental health and nonprofit services. It emphasizes supervision, ethics, and leadership development, with strong hiring outcomes and support from multiple funders and agency leaders.
