Youth activities including afterschool and summer programming - The Organization provides a free or low-cost youth programs to the community. Programming includes, homework assistance, academic enrichment, social/emotional development, leadership development, health and well-being. The Organization works with at risk youth in middle schools, high schools and out of school youth. The Organization also hosts community events including a Holiday Toy Giveaway, Movies Under the Stars and a Spring Street fair. While the majority of programs are provided at no cost to participants, certain activities generate service revenue through program fees.

Social Services - The Organization provides social services programs designed to support vulnerable populations facing barriers to meeting their rental obligations. These barriers may include unemployment, underemployment, disability, health-related challenges, family crises, or other economic circumstances that adversely affect a tenants ability to pay rent.

4c (Code:) (Expenses \$ 172,701 including grants of \$) (Revenue \$)

Economic Development - The Organization provides programs that stimulate business growth and economic activity within the community. This program supports a variety of initiatives, including business development services, workforce development programs, entrepreneurial training, access to capital resources, technical assistance, and other activities designed to improve the competitiveness and sustainability of local enterprises.

(Code:) (Expenses \$ 131,049 including grants of \$) (Revenue \$)

Housing - The Organization engages in housing services that include landlord/tenant mediation, eviction prevention housing court advocacy, crime prevention initiatives, merchant organizing, technical assistance to neighborhood groups, and landlord and tenant forums. These activities are designed to strengthen neighborhood stability, promote safety, and support residents in maintaining secure housing.

Community Development - The Organization provides community service programs that include vaccine education, voting participation initiatives, racial equity and inclusion programming, mental health awareness, and financial literacy workshops. Funding for these programs is derived primarily from government grants.
