SEEDS OF LITERACY PROVIDES FREE BASIC EDUCATION AND GED PREPARATION FOR ADULTS IN GREATER CLEVELAND. WITH A FLEXIBLE ONE-TO-ONE TUTORING MODEL SUPPORTED BY NEARLY 400 TRAINED VOLUNTEER TUTORS, STUDENTS RECEIVE INDIVIDUALIZED INSTRUCTION TAILORED TO THEIR ACADEMIC LEVEL AND PACE. IN FISCAL YEAR 2025, SEEDS EDUCATED 1,599 ADULT STUDENTS. AMONG THESE STUDENTS, 140 EARNED THEIR GED AND 270 PASSED AT LEAST ONE SECTION OF THE GED EXAM, DEMONSTRATING MEASURABLE PROGRESS TOWARD COMPLETION.
