IN 2025, ECOLOGY IN CLASSROOMS & OUTDOORS (ECO) DELIVERED COMPREHENSIVE ECOLOGY AND STEM EDUCATION PROGRAMS TO ELEMENTARY, MIDDLE, AND HIGH SCHOOL STUDENTS THROUGH IN-PERSON ECO LESSONS, AVES COMPARTIDAS DUAL-LANGUAGE PROGRAMMING, PLACE-BASED UNITS, AND ONLINE CURRICULUM. ECO EDUCATORS REACHED 4,080 STUDENTS AT 15 SCHOOLS ACROSS SIX SCHOOL DISTRICTS THROUGH HANDS-ON ECOLOGICAL EDUCATION, SCHOOLYARD EXPERIENCES, AND SERVICE-LEARNING FIELD TRIPS. DURING ECO PROGRAMMING, STUDENTS FROM 136 CLASSROOMS SPENT OVER 9,000 HOURS LEARNING ABOUT AND ENGAGING WITH NATURE. CONTINUED ON SCHEDULE O.
