Providers include Mental Health Professionals, Acupuncturists, Naturopaths, Chiropractors, Massage Therapists, and other complementary Health Care Practitioners. In addition to the amount of program costs of \$139,417 there is an additional amount of \$459,100 for volunteer contributed services which are not included under IRS Form 990 guidelines. The total amount of Network Program costs including volunteer contributed services is \$598,517 which is recognized in our audited financial statements.
