TRANSITIONAL LIVING PROGRAM: FROM JULY 2024 THROUGH FEBRUARY 2025, TSS OPERATED A 9-BEDROOM RESIDENCE FOR FAMILIES LEAVING EMERGENCY, SHORT-TERM SHELTER. FAMILIES HAD ACCESS TO COMPREHENSIVE CASE MANAGEMENT THAT ALLOWED THEM TO BUILD SKILLS TO SUPPORT THEIR GOAL TOWARDS INDEPENDENT LIVING. FAMILIES ALSO HAD ACCESS TO LEGAL ADVOCACY, PERSONAL STABILIZATION SERVICES, FINANCIAL LITERACY, AND HOUSING SEARCH AND ADVOCACY. IN FEBRUARY 2025, THE SECOND STEP ENTERED INTO A STRATEGIC PARTNERSHIP WITH A RENOWNED HOMELESS SERVICES PROVIDER IN ORDER TO TRANSFER OPERATIONS OF THE TRANSITIONAL LIVING RESIDENCE.
