THE IGFA WORKS WITH LIKEMINDED ORGANIZATIONS ON CONSERVATION TOPICS SUCH AS WORKING TOWARDS THE ELIMINATION OF DESTRUCTIVE FISHING GEAR TO ADVOCATING FOR SUSTAINABLE FISHERIES MANAGEMENT.
