PET FOOD AND SUPPLIES THAT WERE PURCHASED BY THE ORGANIZATION WERE GIVEN TO THE NON-PROFITS. SLEEPING CRATES WERE SHIPPED DIRECTLY TO NON-PROFIT HOMELESS AND DOMESTIC VIOLENCE SHELTERS.

EMERGENCY VETERINARY CARE: IN 2025, THERE WERE 2,108 INVOICES TOTALING \$1,172,782 (AVERAGE OF \$556) PAID TO 465 HOSPITALS IN 39 STATES WITH A TOTAL OF 1,621 PETS TREATED; 85% WERE DOGS, 15% WERE CATS WITH AN AVERAGE COST PER PET OF \$723. SOME HOSPITALS GAVE A DISCOUNT. 65% OF THE CALLERS WERE WOMEN, 34% WERE MEN (1% WERE UNIDENTIFIED) AND 12% WERE VETERANS. THE AVERAGE TIME THEY HAD BEEN HOMELESS WAS 3 YEARS AND 5 MONTHS. 28% WERE LIVING IN THEIR VEHICLES.
