SEFAA Center rentals include multi-purpose space rentals, wet studio rentals, and one artist's studio rental. Our artist studio is leased annually and includes a private entrance, a sink, internet and utilities, and round-the-clock access.

Memberships are good for a full year from the date of payment and are rolling, rather than calendar year memberships. Annual membership dues are \$60 for individuals (discounted to \$15 for students and \$55 for members of SEFAA member organizations) and \$100 to \$300 for organizations and businesses depending on their size. Members elect SEFAA's Board of Directors but do not approve Board decisions or share in the Corporation's earnings.
Form 990, Part VI, Section A, Line 7a	Per Paragraph 7.2.2 of SEFAA's Bylaws, Directors are elected at the Annual Meeting of Members held in February each year. Approximately half of the director positions are up for election annually.
