IN OUR EFFORTS TO EMPOWER THE YOUTH OF PITTSBURGH NEIGHBORHOOD IN ATLANTA, GA, WE HAVE CONTINUED AND GROWN OUR MENTORING PROGRAM.IN OUR EFFORTS TO EMPOWER THE YOUTH OF PITTSBURGH NEIGHBORHOOD IN 2011, WE HAVE PAIRED ALMOST 100 MENTOR PAIRS WITH 28 PAIRS CURRENTLY ACTIVE. 56% OF OUR MENTORS ARE ALSO NEIGHBORS. TO PROMOTE COMMUNITY HEALTH, TEAMWORK, AND SELF-CONFIDENCE, WE RUN A FLAG-FOOTBALL LEAGUE EVERY SPRING. IN MAY OF 2025, OUR SPORTS LEAGUE JUST COMPLETED ITS 14TH YEAR OF FLAG FOOTBALL WITH 18 TRAUMA- INFORMED COACHES COACHING 10 TEAMS WITH OVER 145 PLAYERS. THIS YEAR, WE EXPANDED OUR PROGRAM TO INCLUDE LOCAL REFEREES. WE HIRE, TRAINED, AND PAID 8 AMAZING NEIGHTBORS TO BE A PART OF THIS POSITIVE PROGRAM. SEE OUR INSTAGRAM FOR SOME AMAZING HIGHLIGHT REELS AS WE WORK TO EQUIP YOUNG ADULTS IN OUR NEIGHBORHOOD, WE HOST AN ANNUAL 6 WEEK WORKFORCE READINESS PROGRAM FOR YOUTH AGES 18-24, READY4WORK. SINCE 2021, WE HAVE HAD 6 COHORTS AND GRADUATED 14 PARTICIPANTS. MOST WERE PLACED IN INTERNSHIPS AND FOUND EMPLOYMENT OR COLLEGE PROGRAMS SHORTLY AFTER GRADUATION. IN OUR HOUSING PROGRAM, WE HAVE ONLY HAD 2 MONTHS UNUSED IN THE 30+ MONTHS WE HAVE HAD OUR 2 UNITS OPEN. IN 2025 WE GRADUATED 10 YOUNG ADULTS FROM THE PROGRAM. AS WE SEEK TO ENGAGE THE NEIGHBORS OF PITTSBURGH WITH EACH OTHER AND IN MOMENTS OF FLOURISHING, WE HAVE REHABBED AN ABANDONED BUILDING IN THE HEART OF PITTSBURGH AND WE OPENED IN JUNE OF 2023. AT OUR ANNUAL BACK2SCHOOL BASH IN 2025, WE GAVE AWAY 250 FILLED BACKPACKS, HOSTED LOCAL VENDORS, GAVE AWAY HAIRCUTS, PLAYED TOGETHER AND GOT RAINED ON TOGETHER. IN 2025, BLUEPRINT 58 ENGAGED 220 VOLUNTEERS. WE SUPPORTED 7 NEW MENTOR PAIRS, FOR A TOTAL OF 99 SINCE 2011, WITH 52% OF MENTORS LIVING IN THE NEIGHBORHOOD. OUR SMALL GROUP AND ENRICHMENT PROGRAMS INCLUDED 23 PARTICIPANTS IN WEEKLY SMALL GROUPS. 13 TEENS AT SUMMER CAMP, AND 15 YOUTH ON AN OVERNIGHT HIKING TRIP IN PARTNERSHIP WITH THE GEORGIA APPALACHIAN TRAIL CLUB. THROUGH OUR FLAG FOOTBALL LEAGUE, 142 PLAYERS ACROSS 10 TEAMS WERE SUPPORTED BY 50+ VOLUNTEERS, GRILLING AND SERVING 1,920 HOT DOGS TO COMMUNITY MEMBERS. READY4WORK SERVED 10 GRADUATES WITH THE HELP OF 30+ VOLUNTEERS. WE HOUSED 6 NEIGHBORS, PROVIDED TRANSITIONAL HOUSING FOR 2 PARTICIPANTS, AND CONNECTED 40+ NEIGHBORS WITH RESOURCES AND SUPPORT. COMMUNITY-WIDE, WE PARTNERED WITH 31 ORGANIZATIONS, HOSTED 11 NEIGHBORHOOD EVENTS INCLUDING SPRING FLING WITH OVER 300 ATTENDEES AND 30 VENDORS, DISTRIBUTED 250 BACKPACKS FOR BACK-TO-SCHOOL, AND SERVED 260 THANKSGIVING MEALS.
