Agency long-term care ombudsman helped more than 11,100 individuals with issues and problems related to long-term care, including care plans, abuse, restraints, lost or stolen belongings, quality of care, misappropriation of funds, transfers and discharges, and long-term care facility selection. This program utilized \$48,091.26 of donated services.

The agency's legal program assisted more than 7,600 clients with more than 8,100 legal matters, including providing legal advice and representation regarding health issues, public benefits, consumer issues, housing, foreclosure prevention and pensions.
