SECOND HARVEST FOOD BANK HAS BEEN SERVING ORANGE COUNTY'S MOST VULNERABLE POPULATIONS SINCE 1983 INCLUDING CHILDREN AND THEIR FAMILIES, SENIORS ON FIXED INCOMES, VETERANS, PEOPLE WITH DISABILITIES, AND THOSE EXPERIENCING HOMELESSNESS. WE ENVISION AN ORANGE COUNTY WITH FOOD AND NUTRITIONAL SECURITY FOR ALL. OUR MISSION, IN COLLABORATION WITH OUR PARTNERS, IS TO PROVIDE DIGNIFIED, EQUITABLE, CONSISTENT ACCESS TO NUTRITIOUS FOODS, CREATING A FOUNDATION FOR COMMUNITY HEALTH. SECOND HARVEST SOURCES FOOD THROUGH OUR GROCERY RESCUE RETAIL FOOD RECOVERY PROGRAM, LARGE-SCALE DONATIONS, (CONTINUED ON SCH O) GOVERNMENT FUNDING AND PROGRAMS, STRATEGIC PURCHASES, AND HARVESTING PRODUCE AT HARVEST SOLUTIONS FARM AND FOUNDERS FARM. OUR YOUTH HUNGER STRATEGY SEEKS TO ELIMINATE FOOD AND NUTRITIONAL INSECURITY FOR MANY THOUSANDS OF FOOD-INSECURE CHILDREN. OUR PERMANENT AND MOBILE SCHOOL PANTRY PROGRAMS DISTRIBUTE MILLIONS OF POUNDS OF NUTRITIOUS FOOD, SUCH AS FRESH PRODUCE, PROTEIN AND DAIRY, AT NEIGHBORHOOD SCHOOLS AND COMMUNITY CENTERS IN UNDER-SERVED AREAS.
