AS A LEADING ADVOCATE FOR ANIMALS IN OUR COMMUNITY, MCHA CONTINUES TO CHAMPION THE RIGHTS AND WELLBEING OF PETS AND THE PEOPLE WHO LOVE THEM. OUR PET FOOD PANTRY DISTRIBUTED 30,000 POUNDS OF PET FOOD TO HUNGRY PETS. WE PROVIDED 2,400 DAYS OF CRISIS HOUSING FOR PETS WHOSE OWNERS WERE IN TEMPORARY CRISIS, ENSURING THEY REMAINED SAFE AND CARED FOR.
