JUST DEMOCRACY IS A BROAD-BASED AND DIVERSE COALITION THAT WORKS TO PROTECT AND PROMOTE THE VALUE OF A SINGLE VOTE, NO MATTER THE GEOGRAPHIC, RACIAL, ETHNIC OR PARTY AFFILIATION OF THE VOTER.
