EACH GRANT AWARD IS \$150,000 OVER A TWO-YEAR PERIOD, WITH TOTAL RESEARCH FUNDING OF \$1.95 MILLION. RESEARCH GRANT AWARDS WERE SELECTED BASED ON RECOMMENDATIONS FROM THE FOUNDATION'S INDEPENDENT MEDICAL ADVISORY BOARD AFTER A RIGOROUS GRANT REVIEW PROCESS.

PATIENT EDUCATION AND SUPPORT - IN FY25, THE FOUNDATION DELIVERED 11 VIRTUAL EDUCATION PROGRAMS FOR PATIENTS AND CAREGIVERS. THESE PROGRAMS WERE ORGANIZED WITHIN OUR TWO ANNUAL SERIES (LEUKEMIA Q&A AND NEW & EMERGING TREATMENTS), A LEUKEMIA AWARENESS MONTH SERIES (CANCER AND FINANCES AND MINDFULNESS), AND A SPRING SERIES (GENETICS AND NUTRITION). MORE THAN 1,500 INDIVIDUALS REGISTERED FOR THESE PROGRAMS, AND 86% OF PARTICIPANTS RATED THEM AS EXCELLENT OR VERY GOOD. IN ADDITION, FOUR NEW EDUCATIONAL PAGES WERE ADDED TO OUR WEBSITE, PROVIDING INFORMATION ABOUT TESTS ORDERED BY CLINICIANS, WHAT THEY REVEAL, AND HOW THEY GUIDE TREATMENT DECISIONS. THE NEW RESOURCES INCLUDE DIAGNOSIS AND TESTING, LEUKEMIA BLOOD TESTS, BONE MARROW TESTS FOR LEUKEMIA, AND LEUKEMIA BIOMARKER TESTING.
