REPAIRS INCLUDED: 479 FURNACE REPAIR/REPLACEMENTS, 144 ROOF REPAIRS, 222 WATER HEATERS, 45 MAIN DRAIN CLEAN OUTS, 571 PLUMBING CALLS, & 303 ELECTRICAL CALLS. THE TEAM ALSO CONSTRUCTED 49 WHEELCHAIR ACCESS RAMPS AND MODIFIED 49 BATHROOMS FOR HOMEOWNERS WITH REDUCED MOBILITY DUE TO PHYSICAL DISABILITIES.
