THIS FISCAL YEAR, IN COLLABORATION WITH INDIGENOUS BIBLE COLLEGE, THE ORGANIZATION RELEASED ONE OF THE FIRST CHRISTIAN TRAUMA HEALING WORKBOOKS FOR NATIVE AMERICANS, THE MTS NATIVE WORKBOOK, AND COMPLETED SIXTEEN NEW TRANSLATIONS OF HEALING CURRICULUM.
