SALARY INCREASES FOR KEY EMPLOYEES ARE DETERMINED BY THE PRESIDENT BASED ON PERFORMANCE AND APPROVED BUDGET PARAMETERS. WHEN AVAILABLE, COMPENSATION STUDIES ARE USED TO PROVIDE INSIGHT INTO THE APPROPRIATE LEVEL OF COMPENSATION.
